

Before we dive into what we have been upto, we would like to take a moment to congratulate:

- 1. KGBS Board Treasurer, Frank Mwiti on his appointment as the CEO of the Nairobi Securities Exchange.
- 2. Our member Acorn Holdings, who secured \$180 million for affordable student housing, marking a significant milestone in sustainable development.

This monumental achievement was signed during the U.S.-Kenya Business Forum hosted by the U.S. Chamber of Commerce and graced by H.E. President William Ruto in Washington D.C.

The funding is set to drive the development of 35 new affordable student housing units, significantly improving student accommodation across the country, the largest deal by an East African Firm in Affordable Housing.

- 3. Our members, Stella Mutai (HFC), Samuel Kariuki (CEO, Mi Vida), and Raghav Gandhi (CEO, ALP) on their appointment as board members at the Kenya Property Developers Association.

1st Quarter Highlights

1. Real Estate Future Forum - Riyadh, Saudi Arabia

This forum served as a vital platform for industry professionals to engage in discussions on the global real estate sector. KGBS CEO, Nasra Nanda, participated in a panel discussion focusing on sustainable and eco-friendly real estate. Her contribution garnered significant interest, especially as she highlighted opportunities in Africa and shared insights with global real estate players.

The event facilitated collaborative exchange and knowledge-sharing on market trends, investment strategies, and sustainable development. Discussions emphasized the role of cities in shaping communities and the importance of investments enhancing residents' quality of life. Strategies for sustainable finance and improving business quality were also explored.

Nanda emphasized Africa's leadership in climate action, citing recent successes such as the Africa Climate Summit and commitments at COP28. She highlighted Nairobi's role with Africa's first IFC EDGE Green Government Office.

Other discussions focused on the future of green building, aligning with Saudi Arabia's Vision 2030. They emphasized the enduring importance of sustainability in real estate and the need for collaboration for a greener and more profitable future. Prioritizing sustainability is not just an option but a strategic necessity for building a better tomorrow. When we look at sustainability, smart leaders realize that empowering people is key to creating not just sustainable markets but generations of empowered individuals.

Affordable Housing Bill 2023 Submissions at the Kenyan Parliament

In January, the Kenya Green Building Society, led by CEO Nasra Nanda, participated in submissions regarding the Affordable Housing Bill 2023. This effort was part of the broader Kenya Private Sector Alliance (KEPSA) voice, alongside Lydia Oluoch (CEO, KTDA) and Gikonyo Gitonga (CEO, Axis Real Estate Limited). These submissions were presented before a joint committee chaired by Hon. Kuria Kimani, Chairman of the Finance Committee and Urban Committee.

Nasra emphasized the need for adequate representation of Built Environment professionals on the Affordable Housing Fund Board. She also stressed the importance of integrating green principles into the Affordable Housing agenda, citing Kenya's significant demand for climatefriendly projects and finance. Nasra urged Parliament to incorporate green building principles into the bill and emphasized the necessity of legislation on Green Buildings.

Furthermore, Nasra proposed capacity-building sessions in partnership with IFC EDGE, covering the IFC EDGE Buildings rating tool and green legislation



for the built environment, for the joint committee's benefit.

3. Relocation to Shah House, Ngara

In February 2024, KGBS embarked on a significant transition by relocating to Shah House, situated in Ngara Road, adjacent to Sarakasi Dome. This relocation signifies more than just a change of address; it symbolizes a bold stride forward in our mission to spearhead the transformation of the built environment.

Shah House, managed by Urban Africa Partners, stands as a beacon of sustainability, proudly embracing the guidelines set forth by the International Finance Corporation (IFC) EDGE Buildings. With an unwavering commitment to sustainability, Shah House aims for the 'Zero-Carbon' classification, the highest recognition, for all its assets.

As a Green Building Council, our office space reflects our dedication to promoting sustainability in the built environment. This move underscores our resolve to lead by example and champion sustainable practices every step of the way.

5. Webinar: Kenya's Housing Dilemma: Can We Build Affordable AND Green?

In February, KGBS took a significant step forward by hosting its inaugural webinar, centered around the crucial theme of "Unlocking the door to Sustainable and Affordable Homes in Kenya." The webinar served as a platform for in-depth discussions, bringing to light key insights and imperatives for the future of housing in the country.

One fundamental takeaway from the webinar was the interconnectedness of affordability and sustainability in the housing sector. With the ongoing rural-urban migration and rapid urbanization, Kenya faces a pressing housing shortage, often leading to environmentally detrimental developments. The imperative for the government to prioritize affordable housing initiatives not only addresses housing needs but also presents a unique opportunity to drive decarbonization in the building sector, paving the way for a greener future.

Panelists emphasized the importance of adopting smart building practices, leveraging locally sourced and recycled materials, and integrating green infrastructure solutions such as rainwater harvesting and renewable energy. Furthermore, promoting Public-Private Partnerships (PPP) and innovative financing mechanisms emerged as essential strategies to reduce building costs and project delays, making sustainable housing more accessible to a broader population.

In light of these discussions, it became evident that KGBS has a vital role to play in driving forward the agenda for sustainable and affordable housing in Kenya. Through advocacy, education, and collaboration with stakeholders, KGBS is poised to lead the charge towards a future where sustainable homes are the cornerstone of thriving communities and a flourishing environment.



6. IFC EDGE Plaque and Certificate Handover Ceremony at the Nairobi City County Governor's Office

February marked a significant milestone as the Nairobi City County Governor's office became the first government office building in Africa to achieve the IFC EDGE Buildings Green Building standard. The certification ceremony, attended by key stakeholders including IFC representatives and government officials, symbolized a critical shift towards sustainable urban development.

The certification follows the conclusion of the United Nations climate conference in



Dubai 2023, highlighting the pivotal role of cities and local governments in combating climate change. Governor Sakaja Johnson emphasized Africa's potential to lead in sustainable urban design and the importance of cities in shaping the future of the continent.

Mr. Mark Napier of FSD Africa highlighted the importance of partnerships with county governments in realizing sustainable projects, involving various stakeholders from government, developers, and financiers.

Nasra Nanda, representing KGBS, emphasized the significance of the certification for Nairobi, Kenya, and Africa. She stressed KGBS's commitment to promoting green building practices and pushing for green legislation to make Nairobi a model of sustainability.

At KGBS, we advocate for sustainable building practices and strive to transform the Kenyan market towards embracing sustainability in the design, construction, and operation of buildings. This certification marks a significant step towards our goal of creating a greener and more resilient built environment.

This achievement was recognized not just by the IFC EDGE team, but also acknowledged in Forbes Africa. Financing Sustainable and Affordable Housing Workshop – KGBS and Reall.

In collaboration with Reall (UK), KGBS organized a groundbreaking workshop on financing sustainable and affordable housing in Kenya. This exclusive event, titled "A Call to Action: Unlocking Financing Opportunities for Green Affordable Housing for the Kenyan Market," brought together key stakeholders in Nairobi to chart a clear path forward for affordable housing initiatives in the country.

The workshop showcased a pilot guarantee-backed housing deal, heralding an innovative approach with the potential



to unlock significant financing opportunities and realize homeownership dreams for many Kenyans. Nasra Nanda, CEO of KGBS, emphasized the importance of integrating green affordable housing into both private and public sectors, highlighting Kenya's leadership in decarbonizing the built environment.

The discussions centered on the role of guarantees in mobilizing local lending for green-certified affordable housing construction, targeting underserved groups under the Green Affordable Housing Finance (GAHF) framework and IFC EDGE's Green Certification Programme. Reall's Governance and External Affairs Director, Lucy Livesley, underscored the untapped potential of guarantees in attracting climate finance and driving sustainable housing initiatives.

Reall's GAHF initiative, currently piloting a scheme to unlock \$400 million over 15 years, employs an enabling environment facility and guarantee facility to incentivize lending for the construction of green affordable homes and mortgages.

The workshop convened stakeholders from public, private, and not-for-profit sectors, recognizing the urgency of addressing the complex challenges facing residential construction. It emphasized the critical role of multi-stakeholder collaboration in tackling Kenya's affordable housing agenda and emphasized the pivotal role of sustainable finance in driving progress.

This workshop marks a significant step towards mobilizing sustainable finance and fostering partnerships within the built environment, aligning with KGBS's commitment to advancing Green Buildings and contributing to broader goals of Sustainable Urbanization and Affordable Housing in Kenya and beyond. Key industry players, including the IFC, Centre for Affordable Housing, Kenya Property Developers Association, and Kenya Bankers Association, were instrumental in shaping the workshop's agenda and driving meaningful progress towards sustainable and affordable housing solutions.

8. March IFC EDGE Training Workshop

In March, KGBS held an inaugural IFC EDGE Expert



Training. This exclusive training session, facilitated by our esteemed IFC EDGE Faculty, showcased the expertise of industry leaders such as Amrish Shah and our Impact Lead Louis Kariuki, who brought their wealth of knowledge and experience to the forefront.



projects.


